UC Immunization & TB compliance FAQs

Do I need to complete the TB clearance form?

The TB clearance form is only needed for positive TB test result as treatment verification.

Copies of your immunization or lab reports must be uploaded. The result can be uploaded in the patient portal.

Any follow up instruction will be sent you via secure message.

What do I do if an immunization is not available in my area?

Complete the **online** <u>Student Immunization Record form</u> and the **online** <u>Incoming Student TB Screening form</u> and submit all current documentation by **the deadline for your starting quarter**.

Both forms are found in the **<u>patient portal</u>** under the forms link.

If you do not have all required immunizations, upload what you have now.

Deadline exception may be made for students that are unable to complete immunization because the immunization is not available or for proper administration of a dose but forms must be completed and all other immunizations submitted by the deadline for your starting quarter.

Please complete the immunizations that you do not have as soon as you are able to and upload the documentation in your patient portal.

I am missing a vaccine can I fill in the form once again and resubmit?

At this time, the immunization form cannot be edited by the student. Please upload the additional documentation in the student portal and it will be reviewed and updated by SHS staff.

I accidentally submitted the form before it was complete.

At this time, the immunization form cannot be edited by the student. Upload your immunization and/or TB documentation and your records will be reviewed and updated.

Can you review my records and let me know if everything is correct?

Due to the fact that ALL incoming student's records have to be verified, we are unable to reply to all requests to check a student's specific account immediately.

The dashboard within the student portal will show you the status of your compliance. Because of the time required to review all documents allow 4 weeks for updating of any records that you did not enter into your forms.

What kind of documentation is accepted?

Any legally valid document with your name, date of birth, exact immunization and date given, that includes your medical provider's information is acceptable.

If my records are in a different language, do they need to be translated?

Please translate any immunization record that is not in English and submit original record within the patient portal.

What do I name my documents when I upload then in the patient portal?

What can I do if I don't have my immunization record?

You may obtain your Immunization (shot) record from your medical provider, parents or previous school or university.

If you believe you have met the immunization requirements but don't have access to your records, ask your Primary Care provider to order blood tests (titers) for immunity to MMR and Varicella. (Having chicken pox does not exempt you from this requirement. Only evidence of 2 immunizations or a titer showing immunity will be accepted.) Or have all of the immunization again.

However, if you do not have evidence of immunity, you will still need to get vaccinated, contact your medical provider to discuss obtaining the missing dose(s) of the vaccine

You will need to show proof that you have been vaccinated for <u>Tdap</u> on or after age seven, and <u>Meningococcal</u> <u>Conjugate</u> on or after age 16 (if you are under 22 years old).
